FOREMOST 232 ODORLESS CONCRETE CLEANER

DESCRIPTION:

A white granular, dustless powder that contains powerful detergents with emulsifying and penetrating action. It is non-toxic, odorless, safe, efficient, and economical. Contains no caustic or fillers - 100% soluble for fast cleaning action.

APPLICATION:

Recommended for use in removing heavy deposits of grease, oil, grime and dirt in restaurants, kitchens, dairies, meat packing houses, bottling plants, etc. where odor is objectionable. It can be used on unpainted tile, operating equipment, concrete and old wooden surfaces.

DIRECTIONS:

For heavy cleaning, wet the flooring surfaces and sprinkle Foremost 232 Odorless Concrete Cleaner lightly over the wet area. Agitate with an old broom or stiff deck brush to promote solution. Allow to soak from 5 to 30 minutes, then rinse thoroughly with water. On stubborn areas, the procedure may be repeated if necessary.

If desired, for light or medium duty cleaning, pre-dissolve approximately 1 to 3 ounces per gallon of warm water and apply by mopping, brushing, spraying, scrubbing or pouring onto the surface to be cleaned. Follow with a thorough water rinse.

NOTE: For use on unpainted surfaces only. For painted equipment, tile, or concrete, use Foremost 530A Degreaser Concentrate.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN. Contains Sodium Metasilicate. Causes irritation to eyes. Avoid contact with eyes. Do not take internally.
