DESCRIPTION: A unique liquid formulation for keeping dust down on concrete and wood floors or other problem surfaces. It complies with FDA regulation 21CFR 178.3570 lubricants with incidental food contact. Not to exceed 10 ppm.

APPLICATION: Recommended for Food Warehouses, Granaries, Flour Mills, Fertilizer Plants & Warehouses, and any plant where food products are processed or warehoused.

DIRECTIONS:

FOR CONCRETE FLOOR SPRAYING:

1. Fill sprayer approximately $\frac{1}{2}$ full & pump up sprayer. Lock handle.
2. Adjust nozzle to obtain a fine spray mist.
3. Spray a very fine mist (do not wet floor).
4. Sweep floor.
5. Mist over floor again after sweeping to hold dust down until next sweeping or next spraying.

FOR DUST MITT AND BROOMS:

1. Spray a fine light mist on dust mitt or yarn broom and air cure for 6 hours or more.
2. Respray lightly between uses.

PRECAUTIONS: **KEEP OUT OF REACH OF CHILDREN.** May cause eye irritation. Avoid contact with eyes.

FIRST AID: In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Get medical attention immediately if irritation persists.
