FOREMOST 4510 MINTEFFECT

DESCRIPTION: An outstanding synthetic type cleaner. It deodorizes in one operation. Foremost 4510 Minteffect is versatile, serving as a cleaner, and deodorizer for typical restrooms.

APPLICATION: **RECOMMENDED FOR:** Toilet rooms, bathrooms, sinks, kitchens, drain boards, refrigerators, refrigerator cars, cooking rooms and garbage cans.

Institutions such as schools, municipalities, children's homes, colleges, churches, convents, country and athletic clubs, hotels, motels, air lines, bus and railroad terminals find this almost indispensable for daily use.

DIRECTIONS:

1. Clean all surfaces thoroughly before treatment with Minteffect.
2. Apply the use solution with a clean mop, sponge, cloth, squeegee or mechanical scrubber.
3. Prepare a fresh use solution daily. Do not rinse solution.
4. Discard solution when it becomes visibly soiled.
5. Thoroughly wet the surface to be treated with Minteffect at a solution concentration of 2 oz. per gallon (1 part to 64 parts of water) and allow the surface to remain wet for at least 10 minutes. Wipe dry or let air dry.

PRECAUTIONS: **KEEP OUT OF REACH OF CHILDREN:** Causes severe eye and skin damage. Do not get in eyes, on skin or on clothing. Harmful if swallowed. Avoid contamination of food. Wear goggles or face mask and rubber gloves when handling.
