## FOREMOST 4525B LUMBER BRITE

- DESCRIPTION:** Delta Foremost FM 4525B Lumber Brite is a concentrated, industrial-strength cleaner designed to return discolored and faded wood to its new original appearance.
- APPLICATION:** For brightening faded, gray or molded wood stock. Recommended for use in lumber yards, outdoor wood fencing, wood decking and any gray or molded lumber. Do not use on painted or finished wood.
- DIRECTIONS:** Product may be applied as concentrate or diluted up to 5-10 times with water for economy. Fastest results are seen when product is used at lower dilution levels. Apply with a pump-up sprayer. Rinse after application.
- PRECAUTIONS:** **KEEP OUT OF REACH OF CHILDREN. Highly Corrosive. May cause severe eye irritation. Avoid contact with eyes and skin. Do not take internally.**

**FIRST AID:** In case of contact, immediately flush eyes with large amounts of water until burning ceases. Get medical attention immediately if irritation persists. Skin: Wash with plenty of soap and water. Ingestion: Drink large quantities of milk or gelatin solution. If these are not available, drink large quantities of water. Do not give vinegar or other acids. Do not induce vomiting. Seek medical attention.
