

**DESCRIPTION:** 

A quality product designed to neutralize unwanted odors and deodorize the air in bathrooms, kitchens, and any other areas where malodors exist.

APPLICATION:

Foremost FM 4571-ES Bombs Away delivers an ultra-fine citrus-scented mist to effectively freshen rooms up to 6000 cubic feet.

**DIRECTIONS:** 

#### DO NOT USE IN AN AREA LESS THAN 100 CUBIC FEET.

- 1. Place can on raised surface near middle of the room.
- 2. Spread paper or cloth directly below can for protection.
- 3. To lock valve into open position for total discharge, press valve button all the way down, locking the catch.
- 4. Leave room immediately. Stay out of room for at least 2 hours.
- 5. Ventilate area for 30 minutes before re-entry.

**PRECAUTIONS:** 

**KEEP OUT OF REACH OF CHILDREN.** May cause eye and skin irritation. Avoid contact with eyes and prolonged contact with skin. Wash thoroughly after handling. Do not take internally.
