TECHNICAL DATA

FOREMOST 4807 INSECT-O-FOG PLUS

DESCRIPTION: Foremost 4807 Insect-O-Fog Plus is a ready-to-use insecticide that kills on contact the exposed stages of flies, mosquitoes, gnats, silverfish, crickets, spiders, scorpions, wasps, hornets, flying moths, box-elder bugs, clover mites, ants, weevils, confused flour beetles, rust red beetles, cadelles, sawtoothed grain beetles, angoumois beetle, drugstore beetles, cheese skippers, cheese mites, grain mites and many others.

APPLICATION: Recommended for use in dairies, packing houses, granaries, elevators, warehouses and other situations where effective fast acting insecticide is required. As a space or vapor spray, it gives rapid kill of flying stages. As a contact spray it kills certain crawling stages.

DIRECTIONS: It is a violation of Federal law to use this product in a manner inconsistent with its labeling. For best results, use in a good sprayer, or atomizer adjusted to deliver a fine mist. Treat infested areas thoroughly and repeat as needed. Whenever possible, keep windows and doors closed for 10 minutes after spraying. In the control of flying insects, direct the spray toward the upper portions of the enclosure, and fill the atmosphere with mist, using two to three ounces to each 1,000 cubic feet of space. In the control of running and crawling pests, use as a contact and surface insecticide, apply in a good machine adjusted to deliver a coarse droplet spray, using approximately one gallon of material to each 375 square feet of surface. Repeat application as needed.

In mills, elevators, and granaries, spray floors, walls and other surfaces of bin, storage and handling areas thoroughly, with particular attention to cracks, crevices, and similar protective locations. Waste grain, dust, dirt and debris, should be removed and destroyed, and storage areas cleaned before spraying. Treat unloading and processing areas and apply the insecticide to conveying, processing and handling equipment such as the inside of reel conveyors, purifier conveyors, sifters, roll-housing hoppers, pick-up conveyors, etc. Spray thoroughly around the base of heavy machinery and equipment.

Use the product as a space spray in food processing plants only when plant is not in operation. Foods should be removed or covered during treatment. All food processing surfaces should be covered or thoroughly cleaned before using.

STORAGE AND DISPOSAL:

Do not contaminate water, food or feed by storage or disposal.

PESTICIDE STORAGE AND SPILL PROCEDURE: Store upright at room temperature. Avoid exposure to extreme temperature. In case of spill or leakage, soak up with an absorbent material. Dispose of with chemical waste.

PESTICIDE DISPOSAL: Pesticide, spray mixture or rinse water must be disposed of according to label instructions at or by an approved waste disposal facility.

CONTAINER DISPOSAL: Triple rinse (or equivalent) then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other approved state and local procedure.

PRECAUTIONS: **KEEP OUT OF REACH OF CHILDREN. HAZARDS TO HUMANS AND DOMESTIC ANIMALS.** Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. In case of contact, immediately flush eyes or skin with plenty of water. Obtain medical attention if irritation persists. If swallowed do not induce vomiting. Call a physician immediately. Do not apply directly to food. In commercial food handling facilities, cover or remove any food and food processing equipment during application. Do not apply while food processing is under way. After space spraying in meat packing plants, bakeries, and other food processing plants, ventilate the area and wash thoroughly the facilities and equipment with solution of Foremost 1553-ES Super Kleen or any USDA acceptable detergent solution, and then rinse with potable water to remove all traces of contamination from all equipment, benches, shelving, etc., where exposed food will be handled. All food processing surfaces and utensils should be covered during treatment or thoroughly washed before reuse. Remove pets and birds, and cover fish aquariums before spraying.

STATEMENT OF PRACTICAL TREATMENT: EYES AND SKIN: Flush with plenty of water. Contact a physician if irritation persists. **INGESTION:** Contact a physician or Poison Control Center. Do not induce vomiting unless directed by a physician. This product contains a high amount of petroleum distillate. Vomiting may cause aspiration pneumonia. **INHALATION:** Remove affected person to fresh air. Apply artificial respiration if indicated.

ENVIRONMENTAL HAZARDS: This product is toxic to fish. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes. Apply this product only as specified on label.
