FM 4883-ES RESID-U-CIDE

- **DESCRIPTION:** FM-4883-ES Residucide is an EPA-registered residual and contact spray. This solvent-based insecticide is formulated with ETOC for the fastest knockdown possible. Residucide kills a broad spectrum of insects on contact and also contains esfenvalerate for residual treatment up to 7 weeks.
- **APPLICATION:** For use as a residual & contact spray for the control of flying and crawling insects.
- **DIRECTIONS:** It is a violation of Federal Law to use this product in a manner inconsistent with its labeling. Shake Well before using. General: Use this spray as a spot or crack and crevice treatment to control cockroaches, fleas, silverfish, ticks, waterbugs and other insects. Apply this product only as a coarse spray or crack and crevice treatment to localized areas where pests are found or may occur. Spray surface until wet. Repeat as needed. For more specialized treatment methods and a more detailed list of insects controlled, please see product label.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. May cause eye irritation.

Avoid contact with eyes. Do not take internally.
